Know all by these presents, that the undersigned hereby makes, constitutes and appoints each of Shaan Majmudar, Vivian Coates, Thomas Lair Jr., Laura Howell and Marc Parr, signing singly and each acting individually, as the undersigned's true and lawful attorney-in-fact with full power and authority as hereinafter described to:
