- Each Deferred Stock Unit ("DSU") represents the right to receive one share of Common Stock upon vesting. DSUs vest 33% on each of August 26, 2004, 2005 and 2006; however, Mr. Salerno may elect to defer receipt of all or a portion of the shares of Common Stock issuable in respect of vested DSUs until as late as August 25, 2013.
- Deferred Stock Units do not expire.
